

IS Aix en Provence Terms and Conditions of Sale 2024

IS Aix-en-Provence is happy to welcome you. Please note that the following conditions apply:

Registration

To register for an individual course, please send your completed form:

- From our website: www.is-aix.com

- By e-mail: info@is-aix.com

- Or register directly at the school in person

In order for us to validate your reservation, you must pay a non-refundable deposit of: 85 Euros for the enrolment fee + 100 € per course week booked.

You can expect confirmation within 2 working days of submitting your registration form. Your enrolment will be considered final upon receiving our confirmation. The balance payment is due one month before the commencement of the course. Group reservation follow a separate procedure.

Minimum age

IS Aix en Provence warmly welcomes students aged 18 and above throughout the entire year. For students under 18, exceptions are possible on request, if the student is accompanied by an adult or in a closed group with group leaders. A waiver will be required.

Public holidays 2024

The school is closed on public holidays, but this does not impact the weekly lesson count. Compensatory afternoon sessions will be scheduled on certain days to ensure the full classes are covered, resulting in longer class durations on other days. During the week of May 8^{th} and 9th 2024, students will not be able to take the FG+ nor CP course. Public holidays in 2024 are as

January 1 - April 1 - May 1 - May 8 - May 9 - May 20 - July 14 - August 15 - November 1 -November 11 - December 25

Course organization

Each course stipulates a mandatory minimum level in French, and in some cases, there may also be a maximum level requirement. Additionally, a minimum number of students is necessary for a course to be conducted. In case one of these criteria are not respected, IS Aix-en-Provence reserves the right to either transform the course into a different program or cancel the course. Complete beginners joining a group course must adhere to specific starting dates. If a complete beginner is not attending a scheduled date or a student has reached a C2 level, IS Aix-en-Provence reserves the right to either transform the course into a different program or cancel the course.

One lesson has a duration of 45 minutes. The course timetable is transmitted on the first day of class and per consecutive two-week periods. Classes are scheduled by the school. Students are asked to take note of their lesson schedule and to inform of any absence in advance whenever possible.

Missed lessons are forfeited and cannot be postponed, refunded or taken at another time. At the end of the course, students receive a certificate indicating the level studied.

Lessons are given entirely in French. Students are requested to respect the timetables and to be punctual.

Cancellation & Modification of course or accommodation

The following conditions apply:

- more than 14 calendar days before the start of the course: your deposit of 85€ registration fee plus 100€ per course week will be charged and will not be refunded.
- 7 to 13 calendar days before the start of the course: 50% of the balance of the course and 100% of the price of the first week's accommodation with a host family are due.
- less than 6 calendar days before the start of the course: 100% of the course balance and 100% of the first week's accommodation are due.
- repeated changes to a booking will incur a €50 handling fee.

Accommodation

If your preference is to reside with a host family throughout your course, our priority is to secure a suitable placement for you in a homestay. Please communicate any essential information regarding allergies, dietary requirements, smoking preferences, or any other pertinent details that you consider relevant for our consideration.

When living in homestay, a certain closeness is inevitable when sharing meals, kitchen, bathroom and living space. IS Aix-en-Provence and host families cannot be held responsible for any contamination that may occur.

For accommodation in hotels or apartments in private residences, each accommodation has its own protocol and cancellation policy. Any changes must be handled directly between the student and the accommodation partner and, with the exception of homestay, fees must be paid directly to accommodation partners (hotels, residences and private owners). All bookings for accommodation other than homestay will incur a booking fee of 35€.

Payment

Payments to IS Aix-en-Provence can be made via bank transfer, credit card on our website, or by check in Euros endorsed in France, payable to IS Aix-en-Provence. When making a bank transfer, kindly include your first and last name as the reference. Please note that all bank charges are the sender's responsibility.
